ADMISSION REQUIREMENTS

All students applying for admission to the program must submit:

- Official transcripts from the accredited institutions from where you received both your bachelor's and master's degrees
- Resume or CV, and contact information for three references
- Personal statement (no more than 3 pages)
 - How your educational and personal experiences influenced the decision to pursue a DBA
 - Career goals and how this degree will help achieve those goals
 - A research topic or interest area that you plan
 to study
- Participate in a video-conference interview
- Applicants for whom English is a second language must provide English proficiency

Admission decisions are made on a rolling basis throughout the calendar year. For fall semester consideration, all admission items are due no later than May 1. For spring semester consideration, all admission items are due no later than November 1. Applicants are encouraged to submit applicant materials early, as cohort sizes are limited.

FINANCIAL AID

All students are eligible to be reviewed for financial aid. Students will need to complete the FAFSA at **studentaid.gov**. Concordia's school code is: **003842**.

- Students may be eligible for up to \$20,500 per academic year to cover educational related expenses

- No GMAT or GRE required

- Three-year, 60 credit, online (with two required residencies) program features four distinct concentrations:
 - Organizational Performance and Change
 - Healthcare Administration
- Financial and Economic Management
- Business Sustainability
- Designed to address the current challenges facing companies, leaders, and teams in today's business environment
- Develop scholar-practitioner expertise as you learn from industry experts skilled in blending applied learning with theory development
